The Seminar speaker is Dr. Agalya V, working as a professor and Associate Head of R&D. Also she worked in five different institutes and has acted in different roles like Head of the Department and innovation &Entrepreneurship Head. She has completed BE from Periyar University, M.E from Anna University, and received Ph.D. in Electrical Engineering from Anna University. She has around nineteen years of teaching and research experience. Her areas of specialization include Power Electronics, VLSI Design, and Biomedical and Control systems. She has published 21 research papers in Sci & Scopus indexed journals. She has two Indian Granted patents, 15 Indian patents, and designs filed.

The session was hosted by Rachna Palli of the 6th Semester and started with a Welcome Note to our speaker, to all the students of the 4th and 6th semesters students, and to the faculty of the electrical and electronics department. The seminar was preceded by a short talk by the HOD of the electrical and electronics department. In his talk, he emphasized the importance of intellectual property and how to go about enhancing it. After which DR. V AGALYA took the stage and started with the lecture, she made it so easy to understand the lecture to the target audience

by making it an interactive session with the audience everyone was so actively interested in the program.
